"The G61V gas furnaces are the latest products featuring this engineering." Lennox rates the G61V furnace line as the quietest furnaces on the market based on the modified Air- Conditioning and Refrigeration Institute Standard 260, with the sound level based on independent tests of the Lennox G61MPV-36B-070 model and competitive units.

All of the G61V furnaces are also Energy Star products, meeting the Environmental Protection Agency's standards by using at least 20%-40% less energy, which reduces pollution.

"The G61V furnace line is further proof of Lennox Industries' carefully targeted approach to product development," McDonough said. "Lennox intends to be a leader in areas of product innovation that are not only technologically advanced, but also meet consumer needs."
