To grow market share and increase their earnings before interest and tax (EBIT) by \$25 million, Lennox International moved from a national distribution network to a regional distribution, hub-and-spoke network. With broader visibility and regional control, Lennox has increased their productivity by more than 50 percent, and reports their shipping and inventory has reached a 99 percent accuracy rate.
